How to become a member of the Council for Independent Education - CIFE.

Introduction

Thank you for your interest in CIFE membership. This guide explains eligibility, benefits, application process, costs and other obligations. Where detailed information is on the CIFE website, at www.cife.org.uk, this Guide links to the relevant site pages.

Eligibility

CIFE is an association of colleges in which a majority of students are preparing for GCSE, A-level or other comparable post-GCSE examinations. Member Colleges generally have a substantial number of post-sixteen direct entry students and are expected to have a have a current and satisfactory full inspection review or inspection audit from one of the DfE recognised inspecting bodies. Most CIFE colleges are happy to be described as 'Independent sixth-form colleges'.

Benefits of membership

What is CIFE for, and why belong to it?

You'll find quite a bit of information online which will give you a picture of what CIFE is about and why it is worth belonging to. 'About CIFE', and 'Frequently asked questions' are student-facing pages which cover the questions families looking for a CIFE college most often ask. Independent sixth-form colleges compares our sector with mainstream independent schools and Briefing notes gives further information about CIFE and student achievements.

Finally, 'why colleges join CIFE' summarises the direct and indirect benefits colleges enjoy through CIFE membership.

Costs

CIFE is a not-for-profit organisation whose aims, and organisation are described in the <u>CIFE Constitution</u>. Its activities are paid for by subscriptions each college pays, and through commission colleges pay when they enrol students recommended by CIFE.

Subscriptions are calculated from a standard levy plus a sum based on student numbers, up to a maximum of 300 students. In 2014 the smallest college paid just under £500, the largest just under £1500. In practice CIFE's commission income was such in 2014 that it waived subscriptions, but that's not guaranteed to happen every year!

Colleges pay **commission** to CIFE if they recruit students whom CIFE has introduced to them. Commission is based on 10% of the first three terms' fees and is of course only payable when the student pays the college. In recent years commission fees have been CIFE's major source of income and colleges have of course benefitted from the extra enrolments.

Other obligations of membership

Members are of course expected to abide by the <u>CIFE Constitution</u>, and the Membership Application Form (see below) emphasises that. We should also mention that CIFE is a small organisation and as such relies a lot on its members' input to develop new initiatives - but of course members differ considerably in their resources and there is no requirement to devote time to CIFE work.

Application process

The first stage is to <u>contact the CIFE secretary</u> who can answer any questions you may have, put you in touch with CIFE members if need be, and, should you wish, initiate formal application procedures.

Once you have decided to apply we would expect you to send in a completed Membership Application Form (see Appendix 1). The Secretary will then arrange for a senior CIFE principal to visit your college. The purpose of the visit is partly to find out a bit more about your college and partly to give you a more detailed insight into CIFE. It is not an inspection - we rely upon the fact that you will already have been successfully inspected by a DfE recognised body - but your visitor may want to talk about aspects of the inspection report, especially if you have been asked to make improvements.

The final stage is a ballot of members, as described in section 3.4 of the <u>CIFE Constitution</u>.
